Klehr Harrison Launches Atty Professional Liability Group

As the name of the practice suggests, the lawyers' professional liability group represents attorneys and law firms experiencing litigation alleging malpractice or malfeasance. Sherman said the attorneys in the practice also work with clients to reduce their risks and minimize their exposure to possible complaints and torts.

"The market has been growing lately, as trends show that lawyers and law firms are becoming more targeted for litigation," Sherman said. "Even when an attorney does not believe they committed any malpractice, they can be a target for unhappy clients."

Notable colleagues joining Sherman in the lawyers' professional liability practice group include Paige Willan, cochair of the litigation department; former firm general counsel Michael Coran; and former managing partner William Harvey.

Willan told Law360 Pulse in an interview Thursday afternoon that she enjoys representing other attorneys in litigation, saying the professional connections she makes with the clients have been "really rewarding."

"It's great to have that connection with a client who really understands the business and who knows you understand their world," Willan said. "Over the course of my career, I got to work with and represent lawyers I admire, and through that work I've become a better lawyer."

Sherman, who splits her time between Klehr Harrison's Philadelphia and New York offices, joined the firm in 2015, moving her practice over from Willkie Farr & Gallagher LLP. She started her career as a general litigation attorney and soon added professional liability to her practice. Sherman's work also includes commercial contract and business tort litigation, commercial real estate disputes, corporate governance, and labor and employment disputes.

"Lawyers' professional liability work kind of grew organically into my practice," Sherman said. "I successfully defended an attorney in one matter, and it just expanded from there."

Sherman said adding professional liability services to her practice pairs perfectly with her role as the firm's cogeneral counsel, a position she took on in January 2024. She considers the firm and her colleagues at Klehr Harrison her clients and advises them regularly on all aspects of operations, such as ethical conflicts, employment and personnel issues, and risk management.
